3. Reasons for Revisions

We expect our ordinary income for fiscal 2007 to be lower than expected due to tough struggle of sales expansion on new consumer electronics products, drop in sales due to a slump of Media segment. Also having a major impact by a reversal of deferred tax assets, an appraisal loss of US subsidiaries' investment. Accordingly, we have revised the previous forecast of consolidated and non-consolidated business for fiscal 2007.
